

**FIRST AMENDMENT TO THE AGREEMENT BETWEEN
THE COUNTY OF SHASTA AND TECHNICAL RESOURCE MANAGEMENT, LLC DBA
CORDANT HEALTH SOLUTIONS TO PROVIDE DRUG TESTING MATERIALS AND
CONFIRMATION TESTING**

This First Amendment is entered into between the County of Shasta ("County"), a political subdivision of the State of California, and Technical Resource Management, LLC, DBA Cordant Health Solutions, a federally registered trademark ("Consultant").

R E C I T A L S

WHEREAS, County and Consultant have previously entered into an agreement effective July 1, 2022, for the purpose of providing drug testing materials and confirmation testing services ("Original Agreement"); and

WHEREAS County and Consultant desire to amend the Agreement to increase the maximum compensation payable to Consultant by \$100,000 for a new maximum compensation of \$150,000 and to extend the term for an additional one year ("First Amendment"); and

NOW, THEREFORE, the Agreement is amended as follows:

- I. Section 3. **COMPENSATION**, Subsection A. of the Agreement is amended as of the effective date of this First Amendment in its entirety to read as follows:
 - A. Consultant shall be paid according to the prices listed in Attachment A, attached hereto, and incorporated herein, for the services described in this agreement. In no event shall the maximum amount payable under this agreement exceed \$150,000.
- II. Section 5. **TERM OF AGREEMENT**, the agreement is amended as of the effective date of this First Amendment in its entirety to read as follows:

The initial term of this agreement shall begin for one year beginning July 1, 2022 and ending June 30, 2023. The term of this agreement shall be automatically renewed for two additional one-year terms at the end of the initial term, under the same terms and conditions unless written notice of non-renewal is provided by either Party to the other Party at least 30 days prior to the expiration of the initial term or the then current term. Notwithstanding the foregoing, County shall not be obligated for payments hereunder for any future County fiscal year unless or until County's Board of Supervisors appropriates funds for this agreement in County's budget for that County fiscal year. In the event that funds are not appropriated for this agreement, then this agreement shall end as of June 30 of the last County fiscal year for which funds for this agreement were appropriated. For the purposes of this agreement, the County fiscal year commences on July 1 and ends on June 30 of the following year. County shall notify Consultant in writing of such non-appropriation at the earliest possible date.

III. **REAFFIRMATION**

In all other respects, the Agreement, as amended, and any attachments, remains in full force and effect.

IV. **ENTIRE AGREEMENT**

The Agreement, as amended, and any attachments, constitute the entire understanding between County and Consultant.

V. **EFFECTIVE DATE**

Unless otherwise provided, this First Amendment shall be deemed effective as of the last date it is signed by both Parties.


