**AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE
COUNTY OF SHASTA, AMENDING SECTION 19.02.040
OF TITLE 19 OF THE SHASTA COUNTY CODE,
SHASTA COUNTY CARR FIRE, ZOGG FIRE, SALT FIRE, AND FAWN FIRE
DISASTER RECOVERY**

The Board of Supervisors of the County of Shasta, State of California, ordains as follows:

SECTION I.

Section 19.02.040 of the Shasta County Code is amended in its entirety to read as follows:

Section 19.02.040 Effective Period

A. With respect to "Displaced person(s)" displaced by the Carr Fire, the provisions in this Title 19 shall be applicable and remain in effect until May 1, 2024, unless otherwise specified herein, subject to extension or modification by the Board of Supervisors.

With respect to "Displaced person(s)" displaced by the Zogg Fire, the provisions in this Title 19 shall be applicable and remain in effect until September 27, 2023, unless otherwise specified herein, subject to extension or modification by the Board of Supervisors.

With respect to "Displaced person(s)" displaced by the Salt Fire, the provisions in this Title 19 shall be applicable and remain in effect until June 30, 2024, unless otherwise specified herein, subject to extension or modification by the Board of Supervisors.

With respect to "Displaced person(s)" displaced by the Fawn Fire, the provisions in this Title 19 shall be applicable and remain in effect until September 22, 2025, unless otherwise specified herein, subject to extension or modification by the Board of Supervisors.

Unless extended or modified by the Board of Supervisors, this Title shall expire on September 22, 2025, and be of no further force or effect.

B. Unless otherwise provided herein, no interim housing authorized pursuant to this Title shall be used for permanent housing after September 22, 2025.

C. Unless otherwise provided herein, no cargo storage container authorized pursuant to this Title shall be used after September 22, 2025.

SECTION II.

Adoption of this Ordinance is not subject to the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines section 15060(c)(2) since it can be seen with certainty that this Ordinance will not result in a direct or reasonably foreseeable indirect physical change in the environment.

SECTION III.

If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portions of this Ordinance. If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this Ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are severable. The Board of Supervisors hereby declares that it would have passed this Ordinance and every section, subsection, sentence, clause, or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses, or phrases be declared unconstitutional or invalid.

SECTION IV.

All former ordinances and resolutions, or parts thereof, conflicting or inconsistent with the provisions of this Ordinance are hereby superseded by this Ordinance. The adoption of this Ordinance shall not in any manner affect any action or prosecution for violation of ordinances, which violations were committed prior to the effective date hereof, be construed as a waiver of any license, fee, or penalty required by or resulting from any such ordinance or affect the validity of any bond (or cash deposit in lieu thereof) required to be posted, filed, or deposited pursuant to such ordinance.

SECTION V.

This Ordinance shall be and the same is hereby declared to be in full force and effect 30 days after its passage. The Clerk shall cause this Ordinance to be published as required by law.
