Dear Mr. Hellman:

The U.S. Environmental Protection Agency (EPA) is pleased to inform you of the availability of or federal funding via passthrough for noncompetitive direct grant funding under the Inflation Reduction Act (IRA) Sections 60105(a) and 60105(b) providing critical resources to support the sustainability of national air quality monitoring networks. This funding will support establishing new ambient monitoring sites as well as maintaining, operating, or upgrading existing monitoring networks. The statutory authority for this program is utilizing Section 103 of the Clean Air Act (CAA) as the funding authority and does not require matching funds. These funds will be awarded as stand-alone grants and cannot be combined with other grants.

In FY24, we are providing between \$500,000 up to \$1,420,000 to support the operation of your monitoring program. Once EPA reviews all funding requests submitted, we will adjust the regional allocation and consider proposals up to the maximum amount.

Your District will continue to operate the monitors under the terms of the Memorandum of Agreement signed in 1998. You can access the funding allocated to your agency by requesting it from Tung Le at the California Air Pollution Control Officers Association. Please request the entire amount at one time to assist Mr. Le in his management of the funds. Please remember that the funds must be kept and tracked separately. This requires separate accounting, requests for reimbursement and Financial Status Reports.

Shasta County AQMD Ambient Monitoring Upgrade and Resilience Plan

<p>Shasta County AQMD is requesting funding to purchase monitors and supplies to reduce monitor down time in our existing network. Additionally we are requesting funding to purchase a continuous PM10 monitor to provide the community with current PM10 data. The continuous PM10 monitor will replace our Hi-Vol filter-based sampler.</p> <p>Grant funding of IRA Sections 60105(a) and 60105(b) are to be used by Shasta County Air Quality Management District to deploy one new monitors at an existing air monitoring sites, replace ageing monitors and data loggers, provide existing monitor support, and cover staff cost. The expected outcome will support Justice40 by increasing of the resilience of the ambient air monitoring networks, using new ambient air sampling/analysis methods and increase public awareness of ambient air quality. Additionally, one of the ambient monitoring sites (Shasta Lake) for which equipment upgrades would occur through this grant is located in a Disadvantaged Community per the Climate and Economic Justice Screening Tool (Tract Number 06089011600).</p>

Thank you for applying for grant funding under the Inflation Reduction Act (IRA) Direct Monitoring Program.

EPA's Guidance for Air Monitoring Grants and Air Quality Sensors Grants Under the Inflation Reduction Act of 2022 outlined air monitoring priorities and identified factors to allocate the available funding under IRA Sections 60105(a)(b) and (c). Using these factors, EPA Region 9 evaluated the applications submitted by the eligible agencies. The submitted needs of eligible agencies far exceeded the funds available under these IRA monitoring provisions, so many eligible applicants have been allocated less than the amount applied for in their applications.

For the California Air Pollution Control Officers Association (CAPCOA) EPA Region 9 has allocated **\$3,786,025 for the "IRA Section 60105(a)(b) grant (5Q-97T19801-0) and \$55,920 for the IRA Section 60106(c) grant (5U-97T03101-0)**. The breakdown of approved funding amounts by district are as follows:

The next step is to revise the applications for the IRA Section 60105(a)(b) and IRA Section 60105(c) grants, including the work plans and budgets, to match the monitoring priorities with the available funding amounts. Also, EPA is revising the process for grantees to submit their progress reports. The reporting schedule will be included in the programmatic terms and conditions in the final award.
