2. Approval of Agenda and Minutes.
 - 2.1 Agenda - Motion to approve the agenda by Member Wagner, second by Member Corbell. Motion carried.
 - 2.2 Minutes 05/10/23 - Motion to approve the Minutes of last regular meeting and by Member Wagner, second by Member Braun. Motion carried.
3. Reports and Communications:
 - 3.1 Chief Vanlandingham – Fire Department is resuming school visitations.
 - 3.2 Financial Transaction Report – Member Wagner reported that Rob Province, CPA has completed this report with the State of California
 - 3.3 Audit – Member Wagner reported that audit will be completed by September 30th.
