This amendment adds \$232,497.00 to the original agreement amount of \$8,686,020.00 for a total of \$8,918,517.00. This increase is due to an additional position (Battalion Chief) being added to the existing agreement. The new, amended agreement will not exceed \$8,918,517.00. Exhibit D, Schedule A is attached to reflect the new position/ amount of the contract.
