Subject: Termination of the Personal Services Agreement Between County of Shasta, through its Department of Public Works, a political subdivision of the State of California and CGI Technical Services, Inc.

Cliff and Azeddine,

Your firm provides on-call materials testing services to the Shasta County Department of Public Works ("County") through a December 2019 Personal Services Agreement. As that agreement is nearing its functional end and a replacement agreement has been negotiated, the County is exercising its right to terminate the December 2019 agreement without cause pursuant to Article XI, "TERMINATION," of that agreement. In order to expedite execution of the replacement agreement, both parties have agreed to waive the thirty (30) days calendar notice requirement in favor of a terminating the agreement as of the effective date of the replacement agreement.
