**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SHASTA
AMENDING THE SHASTA COUNTY SALARY SCHEDULE**

BE IT RESOLVED that effective retroactive to October 8, 2023, the following amendments are made to the Shasta County Salary Schedule for positions in County service:

An employee in the classification of Correctional Officer I – Deputy Sheriff, Correctional Officer II – Deputy Sheriff, or Correctional Sergeant – Deputy Sheriff who has achieved and maintains an overall performance rating of meets or exceeds standards on their annual performance evaluation shall be eligible for the following non-cumulative longevity pay stipends: two percent (2%) of base pay at three (3) years of continuous Shasta County service; four percent (4%) of base pay at ten (10) years of continuous Shasta County service; five percent (5%) of base pay at fifteen (15) years of continuous Shasta County service.

An employee in the classification of Correctional Officer I – Deputy Sheriff, Correctional Officer II – Deputy Sheriff, or Correctional Sergeant – Deputy Sheriff shall receive five percent (5%) of base pay at twenty (20) years of continuous Shasta County service.

An employee in the Deputy Sheriffs' Association – Correctional Officer – Deputy Sheriffs unit or the Deputy Sheriffs' Association – Deputy Sheriff, Sergeant and District Attorney Investigation unit who has achieved and maintains an overall performance rating of meets or exceeds standards on their annual performance evaluation shall be eligible for the following non-cumulative longevity pay stipends: two percent (2%) of base pay at three (3) years of continuous Shasta County service; four percent (4%) of base pay at ten (10) years of continuous Shasta County service; five percent (5%) of base pay at fifteen (15) years of continuous Shasta County service.

An employee in the Deputy Sheriffs' Association – Correctional Officer – Deputy Sheriffs Unit or the Deputy Sheriffs' Association – Deputy Sheriff, Sergeant and District Attorney Investigation unit shall receive five percent (5%) of base pay at twenty (20) years of continuous Shasta County service.
