### **MINUTES**

8:30 a.m.: Chief Deputy Clerk of the Board Stefany Blankenship called the meeting of the Air Pollution Control Board to order on the above date with the following present:

### **REGULAR CALENDAR**

#### **ELECTION OF 2025 CHAIR AND VICE-CHAIR**

There was no public comment.

By motion made, seconded (Littau/Crye), and carried unanimously, the Air Pollution Control Board elected Member Crye to the position of Chair and Member Littau to the position of Vice-Chair for 2025.

#### **DISCUSSION ABOUT CLIMATE ENGINEERING OPERATIONS**

Member Harmon described a recent agricultural alert from the Farm Bureau concerning a recently withdrawn State rule that would have banned diesel trucks for agricultural transport.

Chair Crye discussed laws in other states that banned cloud seeding efforts and expressed his interest in finding out what actions the Air Pollution Control Board could take regarding such activities.

Sean Ewing, Director of Resource Management, stated that he would like to give a presentation describing the scope and duties of the Board.

**CONSENT CALENDAR**

By motion made, seconded (Munns/Littau), and unanimously carried, the Air Pollution Control Board took the following actions, which were listed on the Consent Calendar:

Approved a budget amendment which increases appropriations by \$469,027 and revenue by \$513,584 in the Air Quality Management District Budget (BU 0373). (Air Quality Management District)

Took the following actions regarding the Inflation Reduction Act (IRA) Direct Monitoring Program grant (Grant): Adopted Air Pollution Control Board Resolution No. 2025-01 which: ratifies the signature on the Grant application; approves the Shasta County Air Quality Management District (District) to participate in the IRA Direct Monitoring Program through the California Air Pollution Control Officers Association (CAPCOA); authorizes the acceptance of funding in the amount of \$227,256; and designates authority to the Air Pollution Control Officer to execute grant agreements and all other documents to implement and carry out the purposes of the Grant, including retroactive so long as they have been approved by County Counsel and otherwise comply with Administrative Policy 6-101, *Shasta County Contracts Manual*; and approved a budget amendment which increases appropriations by \$150,000 and revenue by \$227,256 in the Air Quality Management District Budget (BU 0373). Approved the 2025 Chair's appointments of Supervisor Crye as the member and Supervisor Harmon as the alternate to the Sacramento Valley Basinwide Air Pollution Control Council. (Clerk of the Board)
