WHEREAS, Shasta County has tremendous wealth in natural resources, tourist destinations, outdoor activities, and nationally reknown recreation areas ; and

WHEREAS, there will be no exchange or payment to or from the SCCC or the County of Shasta for functioning as the County's official DMO.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Shasta designates the SCCC as Shasta County's Destination Marketing Organization.

BE IT FURTHER RESOLVED that the Board of Supervisors of the County of Shasta appreciates the efforts of the SCCC and encourages all residents to participate in local opportunities to enjoy the nationally reknown resources of Shasta County.
