**A RESOLUTION OF THE BOARD OF SUPERVISORS
OF THE COUNTY OF SHASTA
ESTABLISHING A COMMITMENT TO ACHIEVE FUNCTIONAL ZERO FOR
VETERAN HOMELESSNESS**

WHEREAS, Shasta County is a place where we honor our veterans, as indicated by this statement on the road signs establishing the boundary lines of the County; and

WHEREAS, Shasta County is committed to ending veteran homelessness in Shasta County by June 2028, as defined by Functional Zero for veteran homelessness; and

WHEREAS, Functional Zero means veteran homelessness is brief and rare. Functional Zero is part of the Built for Zero national movement and methodology, which has helped 12 communities across the nation achieve functional zero veteran homelessness to date; and

WHEREAS, Shasta County is committed to working collaboratively with other local governmental, collaborative and community-based organizations to achieve this goal, and encourages other local agencies and organizations to adopt and pursue this same goal, as the Shasta Advisory Continuum of Care already has; and

WHEREAS, Shasta County is committed to allocating relevant leadership within the Shasta County Health and Human Services Agency, Shasta County Veterans Services Office, and any other relevant agencies to attend a regular county-wide strategy meeting to collaboratively problem-solve and coordinate efforts in pursuit of this goal; and

WHEREAS, Shasta County is committed to allocating relevant frontline staff to participate in regular case conferencing calls to discuss specifically how to house individual veterans who are homeless and to collaborate with other organizations to house as many veterans as possible; and

WHEREAS, Shasta County is committed to proactively seeking out veteran-specific funding or homelessness-related funding that can be used to support homeless veterans; and

WHEREAS, Shasta County is committed to looking for opportunities to direct existing funding, when possible, toward the achievement of functional zero for veteran homelessness and coordinate funding with other local organizations and agencies, when possible; and

WHEREAS, Shasta County is committed to proactively seeking out opportunities to expand housing inventory that veterans can use; and

WHEREAS, Shasta County is committed to sharing updates on progress toward this goal every 6 months.
